This refers to the physical security inspection conducted by Messrs. J. Kelly and R. Caldwell of this office during the period December 3-7, 1984, of activities authorized by NRC Construction Permit CPPR-147 for Wolf Creek Generating Station, and to the discussion of our findings with D. R. Smith and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included the security plan and implementing procedures. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.
