SUBJECT: INSPECTION REPORT NO. 50-271/92-13

This letter refers to the routine safety inspection conducted by Mr. Suresh K. Chaudhary of this office on June 1-5, 1992, at Vermont Yankee Nuclear Power Station, Vermont and Vermont Yankee Power Corporation office in Brattleboro, Vermont. Our inspector reviewed matters important to the health and safety of the public including engineering and technical support to the facility. The results of this inspection were discussed with Mr. D. Reid and his staff at the conclusion of the inspection, and subsequent telephone calls on June 19 and July 7, 1992.

Areas examined during this inspection are described in the NRC Region I inspection report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Overall, the inspection verified that the engineering and technical support activities at the plant were accomplished satisfactorily.
