SUBJECT: Inspection 50-334/84-33

This refers to the routine resident safety inspection by Mr. W. Trostkoski and Mr. D. Johnson on December 10, 1984 - January 7, 1985, at the Beaver Valley Power Station, Unit 1, Shippingport, Pennsylvania. The inspection consisted of document reviews, interviews and observation of activities. The findings were discussed with Mr. J. Sieber and Mr. W. Lacey of your staff.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This violation has been categorized by severity level in accordance with the NRC Enforcement Policy (47 FR 8583) dated March 8, 1984. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL-511.
