Subject: Inspection Nos. 50-317/84-32 and 50-318/84-32

This refers to the routine safety inspection conducted by Mr. P. Clemons of this office on November 26-30, 1984, at Lusby, Maryland, of activities authorized by NRC License Nos. DPR-53 and DPR-69 and to the discussions of our findings held by Mr. Clemons with Mr. Russell and other members of your staff at the conclusion of the inspection, and to a subsequent telephone discussion between Mr. Clemons and Mr. Millis on December 5, 1984.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the inspector follow-up items brought to your attention in the enclosure to our letter dated June 15, 1984. We have no further questions regarding your action at this time.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This violation has been categorized by severity level in accordance with the revised NRC Enforcement Policy (10 CFR 2, Appendix C) published in the Federal Register Notice (49 FR 8583) dated March 8, 1984. You are required to respond to this letter and in preparing your response, you should follow the instructions in Appendix A.

The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
