Gentlemen:

This acknowledges the receipt of your letter dated March 30, 1992, by which you transmitted Revision 14 to the Security Personnel Training and Qualification plan for your facility.

We find the changes in the letter and the attachments thereto to be consistent with the provisions of 10 CFR 50.54(p) with the following exceptions:

- Paragraph 2.2.4 does not define an acceptable "on-the-job" evaluation as required by 10 CFR 73, Appendix B. In addition, it is unclear who will conduct the on-the-job evaluation. Also, it is not clear as to what are the individual's qualifications to make such a determination and certify acceptance for the record.
- Paragraph 2.5 requires suitability and mental test results records be retained for the period of employment plus 3 years. However, 10 CTR 73.56 now requires these records be retained for 5 years. This paragraph must be changed to agree with the new requirement.
- Paragraph 3.1.3 is a degradation of plan commitments. The word "shall" has been deleted from the paragraph.

Paragraph 4.1.4 was not side barred to indicate it was changed.


