On June 26 - July 27, 1984, NRC inspected activities authorized by NRC Operating License Nos. DPR-33, DPR-52, and DPR-68 for your Browns Ferry facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress.

The inspection findings indicate that certain activities violated NRC requirements and other activities appeared to deviate from a commitment to the NRC. The violations and deviations, with pertinent references and elements to be included in your response, are presented in the enclosed Notices.
