## SUBJECT: 10 CFR 50.54 QUALITY ASSURANCE PROGRAM CHANGE REVIEW

The Region I staff has reviewed your most recent submittal in accordance with 10 CFR 50.54(a) and determined that the changes to the Quality Assurance Program Description are acceptable in that the Quality Assurance Program continues to satisfy the criteria of Appendix B of 10 CFR Part 50. If there are changes to other operative QA commitments existing in docketed correspondence outside of the Quality Assurance Program Description, you are obligated to notify this office. Implementing such changes should be based on 10 CFR 50.54(a)(3).

The effectiveness of your Quality Assurance Program and procedure implementation will continue to be the subject of routine regional inspections.
