Dear Ms. Puntteney:

This is a partial response to your letter dated June 30, 1984, in which you requested, pursuant to the Freedom of Information Act, copies of documents pertaining to (1) any or all documents and materials pertaining to the Full Scale Joint Emergency Exercise held at the Enrico Fermi 2 Atomic Power Plant on June 26 and 27, 1984, and (2) any or all documents and materials pertaining to whether the Fermi 2 nuclear plant meets the standards outlined in 10 CFR 50.47 (Emergency Plans).

In accordance with your telephone conversation with Mrs. Pappas, of my staff, on July 19, 1984, you agreed to an extension of time on your request and to pay the reproduction charges.

Enclosed are the documents listed on Appendix A, which are responsive to your request.

The charge for reproducing records not located in the NRC Public Document Room is five cents (\$0.05) per page, as specified in 10 CFR 9.14(b). Accordingly, the cost of reproducing the 832 pages is \$41.60. You will be billed for this amount by our Division of Accounting.

The search for and review of additional documents subject to your request have not been completed, as soon as search and review are completed we will advise you of our disclosure determination.
