Dear Ms. Garde:

This is in partial response to your letter of May 22, 1984, in which you requested, pursuant to the Freedom of Information Act, copies of all documents compiled in the course of inspections/investigations conducted by Region II into allegations of violations of the Atomic Energy Reorganization Act, as amended, regarding Duke Power Company.

The documents listed on Appendix A are being placed in the NRC's Public Document Room (PDR). Documents which you submitted to the NRC and documents which the NRC sent to you have been deemed outside the scope of your request and are not addressed in this response.

The documents listed on Appendix B (with the exception of those documents marked with an asterisk which are already publicly available at the PDR) and the documents listed on Appendix C are investigatory records compiled for law enforcement purposes and are being withheld from public disclosure in their entirety pursuant to Exemption (7)(A) of the Freedom of Information Act (5 U.S.C. 552(b)(7)(A)) and 10 CFR 9.5(a)(7)(i) of the Commission's regulations. The document listed on Appendix D is being partially withheld pursuant to Exemption (7)(A). The nonexempt portion of this document is your letter dated October 28, 1983, to William J. Dircks regarding his October 24 response to your October 6 letter to the Chairman of the NRC. Disclosure of the denied information in this paragraph would interfere with an ongoing enforcement proceeding.

In addition, some documents on Appendix B, and each document listed on Appendix C contain certain information regarding allegations that were made, the names of confidential sources, and personal privacy information such as home addresses and telephone numbers. The documents on Appendix B are identified by the number 6 to the right of each document description. To disclose this type of information in a preliminary agency record

which does not reflect the agency's findings regarding the validity of the allegations or incidents described would constitute a clearly unwarranted invasion of personal privacy of these individuals, and reveal confidential sources. These documents are being withheld in their entirety pursuant to Exemptions (6) and (7)(C) of the Freedom of Information Act (5 U.S.C. 552(b)(6) and (7)(C)) and 10 CFR 9.5(a)(6) and (7)(iii) of the Commission's regulations.

Pursuant to 10 CFR 9.9 and 9.15 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The person responsible for the denial of documents listed on Appendices B and D is Ben B. Hayes, Director, Office of Investigations. The persons responsible for the denial of documents listed on Appendix C are the undersigned and Mr. James P. O'Reilly, Regional Administrator, Region II.

The denials by myself and Mr. O'Reilly may be appealed to the Executive Director for Operations within 30 days from the receipt of this letter. As provided in 10 CFR 9.11, any such appeal must be in writing addressed to the Executive Director for Operations, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision." The remaining denials may be appealed within 30 days to the Commission and should be addressed to the Secretary of the Commission.

The search for and review of additional documents subject to your request has not been completed. As soon as the search and review have been completed, we will contact you.
