Dear Ms. Cunningham:

This is in further response to your letter of June 13, 1984, in which you requested, pursuant to the Freedom of Information Act, documents regarding OI's review of operator training at Grand Gulf I Nuclear Power Plant.

The documents listed on Appendix A are subject to your request and are being withheld in their entirety pursuant to Exemption (7)(A) of the Freedom of Information Act (5 U.S.C. 552(b)(7)(A)) and 10 CFR 9.5(a)(7)(i) of the Commission's regulations because release of these documents would interfere with an ongoing investigation. For your information, while conducting this investigation NRC became aware of certain information which warranted attention by the Department of Justice (DOJ). This matter has been referred to DOJ for appropriate action. Our records indicate that this matter is still pending DOJ action.

Pursuant to 10 CFR 9.15 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure and that its production or disclosure is contrary to the public interest. The person responsible for this denial is Ben B. Hayes, Director, Office of Investigations.

This denial may be appealed to the Commission within 30 days from the receipt of this letter. Any such appeal must be in writing, addressed to the Secretary of the Commission, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision."

This completes NRC's action on your request.
