INDEPENDENT REVIEW OF ZIMMER PROJECT MANAGEMENT

BI-WEEKLY STATUS REPORT NO. 1 FOR THE PERIOD ENDING MAY 6, 1983

The status report below is in reference to the Torrey Pines Technology Program Plan, document number GA-C17044, "Independent Review of ZIMMER Project Management," dated March 1983.

Prior to this reporting period, a program plan was prepared and presented to CG&E and the NRC, responses were prepared to questions from CG&E and the NRC, project information documents and organization charts were obtained and studied and initial drafts were prepared for the review procedures and checklists. A formal NRC public meeting was attended in Cincinnati on April 25 at which the program plan was presented.

The initial survey team visit to ZIMMER took place during the week from May 2 through May 6, 1983. During the first two days various ZIMMER Department Managers made presentations for their areas of responsibility based on Attachment 1. On the third day, the review team toured the ZIMMER plant, scheduled personal interviews with the assistance of Admiral William's secretary, identified documentation to be provided by CG&E, prepared questions for the people to be interviewed and began the interviews which were completed during the remainder of the week.

Enclosed for your information is a copy of TPT's in-house Quality Assurance Program Document for the Independent Management Review of the Zimmer Nuclear Plant Project Document No. QAPD 2474, Issue B. This document complies with the statement in our proposal that the Zimmer review will be conducted under a documented QA program prepared specifically for this project, utilizing the NRC-approved GA Quality Assurance Program.

The document was originally prepared (but not issued) in late March in anticipation of an earlier formal authorization by NRC to proceed. We have complied with this QAPD since that date.

As discussed with Mr. Sagar, we have deleted any requirment for CG&E approval, but have indicated Mr. Dickhoner on Figure 1 as the responsible CG&E officer with whom TPT will interface. Please advise us if you wish to designate an alternate.
