SUBJECT: INSPECTION REPORT NOS. 50-269/92-14, 50-270/92-14 AND 50-287/92-14

This refers to the inspection conducted by P. E. Harmon during the period May 24 - June 19, 1992. The inspection included a review of activities authorized for your Oconee facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed inspection report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress

In addition, one apparent violation was identified and is being considered for escalated enforcement action in accordance with the "General Statement of Policy and Procedure for NRC Enforcement Actions" (Enforcement Policy), 10 CFR Part 2, Appendix C (1992). The apparent violation involves a failure to maintain two emergency feedwater flow paths operable between May 11 and May 24, 1992, as required by Technical Specification 3.4.1, Emergency Feedwater System. Accordingly, no Notice of Violation is presently being issued for this inspection finding. Please be advised that the number and characterization of this apparent violation described in the enclosed inspection report may change as a result of further NRC review.

An enforcement conference to discuss this apparent violation has been scheduled for July 17, 1992. The purposes of this conference are to discuss the apparent violation, its cause and safety significance; to provide you the opportunity to point out any errors in our inspection report; to provide an opportunity for you to present your proposed corrective action(s); and to discuss any other information that will help us determine the
