Gentlemen:

This refers to the Systematic Assessment of Licensee Performance (SALP) Board Report of the Wolf Creek Generating Station. The SALP Board met on October 25, 1984, to evaluate the performance of the subject facility for the period August 1, 1983, through September 30, 1984. The performance analyses and resulting evaluations are documented in the enclosed SALP Board Report.

The performance of your facility was evaluated in the selected functional areas identified in Section IV of the enclosed SALP Board Report.

The overall performance of Kansas Gas and Electric Company at the Wolf Creek Generating Station indicates a high level of dedication to nuclear safety as well as a high degree of technical competence in diverse areas essential to the safe construction, testing, and operation of the facility. The coordination between the applicant's construction and operation's staff during this transitional phase is commendable.

It is of significant merit that the facility received Category 1 ratings in the following functional areas: Support Systems, including HVAC and Fire Protection; Instrumentation and Control Systems; Licensing Activities; Radiation Protection; and Environmental Surveillance. Additionally, a general trend toward more favorable ratings when compared with the previous SALP evaluation is noted. However, the decline in performance category ratings for the functional areas of construction quality assurance and electrical power supply and distribution systems, as well as the Category 3 rating for emergency preparedness, suggest a need for continued aggressive management attention.
