I reviewed the amended licence and have a few comments:

- 1) The source models (C-170, C-171) are missing from condition 10.A Gammacell 100
- 2) The formatting of the typed line for condition 10.D Theratron B, F needs to separate C-146 from the device model (ie. Theratron B, F C-146, C-151) to avoid confusion.
- 3) An asterisks note (\*) that was listed under license condition 10 is missing from this amended license:
- " \* or sealed source as designated on customer's license"

This asterisks should be applied to ALL sealed source model numbers listed in Condition 10.B - 10.D. It appears this small detail was missed when amendment 8 (2015) was issued, when the format switched from portrait paper to landscape paper.

Please advise if these can be corrected. Thank you.
