This refers to the inspection conducted by Mr. D. Johnson of this office on January 15-19, 1979 at Calvert Cliffs Nuclear Power Plant, Units 1 and 2, Lusby, Maryland of activities authorized by NRC License Nos. DPR-53; DPR-69 and to the discussions of our findings held by Mr. Johnson with Mr. L. Russell and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the Office of Inspection and Enforcement Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Our inspector also verified the steps you have taken to correct the items of noncompliance brought to your attention in letters dated November 17, 1978 and November 30, 1978. We have no further questions regarding your action at this time.

Within the scope of this inspection, no items of noncompliance were observed.

In accordance with Section 2.790 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations, a copy of this letter and the enclosed inspection report will be placed in the NRC's Public Document Room. 

The information sought to be withheld shall be incorporated as far as possible into a separate part of the affidavit. If we do not hear from you in this regard within the specified period, the report will be placed in the Public Document Room.
