An announced inspection was conducted by Mr. Thomas Dragoun of this office on August 11-13, 1992 of NRC authorized decommissioning activities. Discussions of our findings were held by Mr. Dragoun with you and other members of your staff at the conclusion of this inspection.

Areas reviewed included status of decommissioning, radiation worker training, effluent monitoring, and the radwaste program. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this review, no safety concerns or violations were observed. The previously noted trend of improvement in your program is continuing. No reply to this letter is required.
