

SUBJECT: RESPONSE TO NRC INSPECTION REPORT 50-313/92-16; 50-368/92-16

Thank you for your letter of August 3, 1992, in removes to our letter and Notice of Violation, lated July 2, 1992. We have reviewed your reply and find it responsive to the concerns raised in our Notice of Violation. We note as you indicated, that the requirement to render procedures inactive was not effective until September 16, 1991. We would bring to your attention that Procedure 1000.139, "Periodic Review of Procedures," Revision 0, dated September 16, 1991, did not specifically exclude procedures that had been reviewed before the effective date, nor does it provide instruction on its implementation for previously reviewed procedures.

The integrated schedule you provided in response to the other inspection findings was found to be acceptable.

We will review the implementation of your corrective actions during a future inspection to determine that full compliance has been achieved and will be maintained.
