Enclosed is the report of the August 17-19, 1992 inspection, led by Mr. J. Lusher, of Calvert Cliffs Nuclear Power Plant Emergency Preparedness (EP) and of the partial-participation, annual EP exercise. Our inspection findings were based on inspector observations, discussions with your staff, and document review. At the end of the inspection, the preliminary NRC findings were discussed with members of your staff.

Overall, exercise performance demonstrated the ability to protect public health and safety. Exercise strengths included recognition of potential degradations in plant and emergency response facility conditions, diagnosis and mitigation of accident conditions, and deployment of maintenance teams. No violations or exercise weaknesses were identified. Areas for improvement included exercise and scenario control, plant public address announcements, and status board maintenance in the Technical Support Center.
