The attached Report Number NIS-1-00009 provides the Inservice Inspection (ISI) Summary report for the period ending with the fifth refueling outage (RF05) for Grand Gulf Nuclear Station (GGNS). This report is provided in accordance with the requirements of ASME Section XI, Article IWA-6000, which is incorporated by reference into 10CFR50.55a(g).

Report Number NIS-1-00009 contains an overall summary of inservice inspections performed since November 27, 1990 to June 9, 1992 on the GGNS Unit 1 reactor pressure vessel, piping, components, and component supports. NIS-2 Forms, which provide information concerning ASME Section XI repairs and replacements, are also included. All open items identified in this report are listed on Page 126; the resolution of these items will be reported in NIS-1-00010 after RF06.
