At the conclusion of the site visit, the preliminary findings were discussed with Mr. Paul Caudill and members of your staff identified in the enclosed inspection report.

Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations of activities in progress.
