This report transmits the findings of the safety inspection conducted by the resident inspectors at the Calvert Cliffs Nuclear Power Plant. At the conclusion of the inspection, these findings were discussed with you, Mr. Cruse, and Mr. Dettner.

Areas examined during this inspection are described in the attached NRC Region I Combined Inspection Report and were selected to ensure that your facility is operated with due regard for the public health and safety. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspectors.

Overall, we have concluded that your facility was operated safely. Operators conducted startup activities at Unit 1 and responded to a reactor trip at Unit 2 well. The report discusses the identification by your staff that four plant personnel entered a posted high radiation area without proper documentation and dose rate monitoring. In order to complete a timely review of this issue a special inspection is being conducted by the resident staff.
