SUBJECT: SAN ONOFRE #2 SECURITY PROGRAM

Procedures for Granting Interim (up to 90 days) Access Authorization

- I. For unescorted access to protected areas and occupied Type II\* vital areas:
  - a. Positive identification check (driver's license or comparable means) and,
  - b. Telephone (or written) check of trustworthy employment in previous 12 month period.
- II. For unescorted access to Type I\* vital areas:
  - a. Procedures as set forth in the Physical Security Plan for permanent access or,
  - b. As set forth in I a & b above, plus two-man rule (buddy system).

Access Controls During Emergency ConditionsI. Offsite Emergency Response Personnel

During the initial period of an emergency, the following requirements may be waived for offsite emergency response personnel:\*

- (a) search and identification of personnel as specified in §73.55(d)(1),
- (b) search of all hand-carried items as specified in §73.55(d)(2),
- (c) search of vehicles required by §73.55(d)(4),
- (d) use of a badge identification system required by §73.55(d)(5), and
- (e) registration of response personnel as specified in §73.55(d)(6).

provided that licensee security personnel with communications equipment are assigned as escorts so that:

- (a) at least one escort is assigned to each emergency vehicle, and
- (b) all emergency response personnel remain within the view of an escort at all times unless doing so presents an immediate danger to the escort (i.e., fire situations).

II. Onsite Emergency Response Personnel

During the initial period of an emergency all vital area access controls required by 10 CFR 73.55(d)(7) may be waived for authorized onsite emergency response personnel.\*

The point in time for reinstatement of access controls would have to be determined on a case by case basis.

\* These provisions would also apply to situations that could lead to emergency conditions. All such waivers would be reportable under 10 CFR 73.71(c).
