Thomas Applegate called to speak to the Chairman. The call was referred to Norm Haller.

Mr. Applegate referred to an exchange of correspondence -- an August 16, 1982 letter from himself to Chairman Palladino and a September 20, 1982 response from James Cummings (both letters attached).

Applegate stated that one of the chief crackers behind this is Cummings. Cummings is the one who perpetrated the coverup at NRC -- he deleted portions of the OLA report. The investigation was stopped because of him. His office kept putting him (Applegate) off until he finally got to Commissioner Ahearne.

Applegate commented that this (presumably, the referral of his August 16 letter to Cummings) is one of the funniest things he's theard.

Applegate said to tell the Chairman: "I got the letter from ... Cummings. Who's kidding who?" He assumed that members of the NRC staff were also laughing at that!
