NOTICE OF WITHDRAWAL OF APPLICATION FOR

AMENDMENT TO FACILITY OPERATING LICENSE

The United States Nuclear Regulatory Commission (the Commission) has granted the request of the Power Authority of the State of New York (the licensee) to withdraw its April 19, 1991, application for proposed amendment to Facility Operating License No. DPR-59 for the James A. FitzPatrick Nuclear Power Plant, located in Oswego County, New York.

The proposed amendment would have added new specifications regarding operability requirements for ventilation and air conditioning equipment associated with four environmental enclosures at the FitzPatrick plant.


The Commission has previously issued a Notice of Consideration of Issuance of Amendment published in the FEDERAL REGISTER on May 29, 1991 (56 FR 24215). However, by letter dated September 9, 1992, the licensee withdrew the proposed change.
