SUBJECT: COMBINED INSPECTION REPORT NOS. 50-352/92-23 AND 50-353/92-23

This letter transmits the results of the resident safety inspection by Messrs. T. Kenny, L. Scholl and S. Sherbini, from July 19 - August 29, 1992, at the Limerick Generating Station, Limerick, Pennsylvania. The inspection focused on the observation of activities important to ensuring the public health and safety. Reviews of documents and interviews of plant personnel were also performed. The results have been discussed with Mr. J. Doering of your staff.

The resident inspectors have commented favorably on the physical condition of the facility after over 400 days of operation. The operation of Unit 2, during that period, without a unit trip is an indicator of your staff's attention to quality and safe operation.

No written response to this letter is required. In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the Public Document Room.
