SUBJECT: DRAFT OF A PROPOSED RULE THAT WOULD EXPAND NRC'S CRIMINAL
PENALTY PROVISIONS

I have enclosed a draft proposed rule which Jim Lieberman requested that my staff prepare that would have the effect of identifying the sections in 33 Parts of 10 CFR Chapter 1 as being issued under 42 U.S.C. 2201(b), (i), and (o) except those which relate to housekeeping matters. (Enclosure 1) Also enclosed is a listing which identifies the additional sections in each Part which would be subject to (b) (i) and (o) as a result of this action. (Enclosure 2)

The Statement of Considerations that we have included in the draft proposed rule is limited. We believe that an extensive discussion is needed in the Statement of Considerations to indicate why the sections being identified for the first time are now being issued under (b), (i), and (o) when they were not considered so in the past. We believe that such a discussion is essential because a proposed rule that would allow potential criminal sanctions for a significant number of new activities will probably generate substantial interest. Because of the large number of new sections that will be covered we believe that consideration should be given to revising the authority citations on a part by part schedule rather than to attempt the conversion of 10 CFR Chapter 1 at one time.

It is our view that issuance of this proposed rule should be a joint effort of the Office of the General Counsel and the Office of Enforcement. My staff will be available to perform its normal assistance in reviewing the proposed rule to assure compliance with Federal Register publications requirements.
