Gentlemen:

This refers to the special safety inspection conducted by Messrs. R. Mendez, Z. Falevits, K. Tani, and A. S. Gautam of this office on December 19-20, 1984, January 3-5 and 10-12, 1985, of activities at Enrico Fermi Nuclear Station, Unit 2, authorized by NRC Construction Permit No. CPPR-87 and to the discussion of our findings with Dr. W. H. Jens and Mr. W. R. Holland at the conclusion of the inspection.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

During this inspection, certain of your activities appeared to be in noncompliance with NRC requirements, as specified in the enclosed Appendix. A written response is required.

Additionally, several other matters concerning the adequacy of your electrical as-built configuration and related design documents are identified in the enclosed report. These matters represent additional examples of items of noncompliance discussed in Inspection Reports Nos. 50-341/84-62, 84-57, 84-50, 84-45, 84-35 and 84-17. Further, these issues were discussed with you and members of your staff during meetings in the Region III office on December 5, 10, and 31, 1984. You have committed to take and are taking major corrective actions to address our concerns in this area. Pending completion of your effort and our review of your action, these issues have been characterized as unresolved items. These items need to be resolved satisfactorily prior to our recommending a low power license for your facility. Consequently, in your response to this letter please include the corrective action you are taking to resolve each of these items.
