Gentlemen:

Under the provisions of 10 CFR 170 ("Fees for Facilities and Materials Licenses and Other Regulatory Services ..."), this office is responsible for notifying licensees of fees due for the review of applications for license amendments and other approvals for nuclear facilities. For applications filed prior to June 20, 1984, Section 170.12(c) of the March 23, 1978 regulations requires licensees to provide their proposed fee determination of the amendment fee class, state the basis therefor, and remit the fee corresponding to the determination with each application. When fees are not paid or the fee is not appropriate, additional fees are requested or refunds are made by us based on information provided by the NRC review staff. For those applications filed on or after June 20, 1984, Section 170.12(c) of the June 20, 1984 regulations requires licensees to remit an application fee of \$150 with each application for license amendment, exemption, relief or other request. Subsequently, licensees are billed for any additional costs for the review of these applications in accordance with 10 CFR 170.12(c) and 170.21.

We have completed a review of most of the applications for license amendments and other requests which your Company has filed with the Office of Nuclear Reactor Regulation (ONRR) for the Grand Gulf Nuclear Station Unit No. 1 over the last approximately two years. As a result of this review, we find that fees pursuant to 10 CFR 170 were not remitted with several of your applications, or that the ONRR staff's fee determinations are different than those of your Company. Therefore, enclosed is a list which shows the application dates, fees paid, fees that are applicable, and the ONRR staff's fee determination and action for each of them. Based on the ONRR staff's fee determinations, a total of \$37,200 is due the NRC for applications filed since April 1983 that are referred to on the list. Your Company is requested to remit this amount to our office. If the staff's final review of those items shown on the enclosed list as still pending reveal that the fees being requested are not correct, you will be notified and any necessary adjustments will be made.
