SUMMARY

Scope: This special, announced inspection involved eight inspector-hours on site in the area of licensed operator training with regard to Amendment 13 to the Grand Gulf License No. NPF-13.

Results: In the area inspected, no violations or deviations were identified.

2. Exit Interview

The inspection scope and findings were summarized on September 6, 1984, with those persons indicated in paragraph 1 above.

3. Licensee Action on Previous Enforcement Matters

Not inspected.

4. Unresolved Items*

Unresolved items were not identified during this inspection.

5. Licensed Operator Training on Amendment 13 to Grand Gulf License No. NPF-13

On or about August 3, 1984, all licensed personnel at the Grand Gulf Nuclear Station attended a Technical Specification Training Class (TST-84169) addressing the (then) proposed Amendment 13 to Grand Gulf License No. NPF-13. Operations Department personnel who had been closely involved in the development of Amendment 13 determined which changes to the Grand Gulf Technical Specifications would be of most importance to, and have the greatest impact on, the licensed operators. This preliminary training session was to be reinforced in greater detail after the issuance of the Amendment.

During the period from August 16, 1984 through September 6, 1984, all licensed personnel at the Grand Gulf Nuclear Station, with the exception of three SRO-licensed instructors, received additional training on Amendment 13 to Grand Gulf License No. NPF-13. During these training sessions, an

SRO-licensed Operations Assistant, who had taken part in the Amendment negotiations, reviewed the entire Amendment in detail. Since the Amendment was not issued until August 31, 1984, all those individuals who attended the additional training prior to that date will receive a memorandum detailing those few, minor instances where the final, issued Amendment differs from the proposed change used as the basis for the additional training. These differences were determined by the licensee to have no impact on the operators' ability to safely operate the plant.

The inspector reviewed the material presented to the licensed personnel during the preliminary and additional Technical Specification Training Classes and found it to be satisfactory. Attendance records were verified to ensure that all licensed personnel had completed the required training prior to assuming licensed duties; no discrepancies were noted. Those three SRO-licensed instructors who have not received the additional Technical Specification training as of August 6, 1984, must do so prior to assuming licensed duties. This item will be identified as Inspector Followup Item 84-24-01, Instructor Amendment 13 Training.

The inspector interviewed three licensed operators with regard to the salient Technical Specification changes included in Amendment 13 to Grand Gulf License No. NPF-13. Based on this sample, the training provided to the licensed operators on Amendment 13 appears to have been adequate and effective.
