Dear Mr. Lodge:

This is in final response to your letter dated July 27, 1983, in which you requested, pursuant to the Freedom of Information Act, documents generated or received by the NRC since March 31, 1982, concerning Hayward Tyler Pump Company (HTPC).

The documents listed on the Appendix to this letter are subject to your request. Documents 1 through 13, 15 through 31, and 38 are enclosed and are being placed in the NRC Public Document Room (PDR). Portions of documents 14, 32 through 37, and 39 are being withheld from public disclosure. The nonexempt portions of these documents are enclosed and are being placed in the PDR.

Portions of documents 14, 32, and 37 are being withheld because they contain the names of customers who purchased spare parts from the HTPC, the serial number of the pump, the plant at which the pump is located, and other information which is considered company confidential (proprietary information). This information is being withheld pursuant to Exemption (4) of the Freedom of Information Act (5 U.S.C. 552(b)(4)) and 10 CFR 9.5(a)(4) of the Commission's regulations.

Portions of documents 33 through 37, and 39 are being withheld from public disclosure because they contain names of individuals who were interviewed or mentioned during interviews in the course of an NRC investigation. In reviewing the totality of the circumstances under which the information was provided, NRC believes that disclosure of these names would constitute an unwarranted invasion of personal privacy because it could jeopardize their current and future employment, as well as their standing in the community. Consequently, the names are being withheld pursuant to Exemption (7)(C) of the Freedom of Information Act (5 U.S.C. 552(b)(7)(C)) and 10 CFR 9.5(a)(7)(iii) of the Commission's regulations.

Portions of documents 33 through 37, and 39 are being withheld from public disclosure because they contain the names of confidential sources. These names are being withheld pursuant to Exemption (7)(D) of the Freedom of Information Act (5 U.S.C. 552(b)(7)(D)) and 10 CFR 9.5(a)(7)(iv) of the Commission's regulations.


During the search for records subject to your request, the staff located an IBM Office System 6 word processing diskette labeled "Disk 2, Matakas, #972, Hayward Tyler Rpt., Job A -- Allegations No. 1 thru 26, Job B -- Results of Interview (7) and (2) Sworn Statements." This was the only diskette located. This diskette was output and the paper copies are documents 35 and 39 on the appendix to this letter.

During the processing of your request, two pages of handwritten notes regarding route sheets were located and identified as being subject to your request. However, during the reproduction of documents, these two pages were lost. We have been unable to locate another copy of these pages.

Pursuant to 10 CFR 9.9 of the Commission's regulations, it has been determined that the information withheld is exempt from production or disclosure, and that its production or disclosure is contrary to the public interest. The persons responsible for this denial are the undersigned and Mr. Richard C. DeYoung, Director, Office of Inspection and Enforcement.

This denial may be appealed to the Commission's Executive Director for Operations within 30 days from the receipt of this letter. As provided in 10 CFR 9.11, any such appeal must be in writing, addressed to the Executive Director for Operations, U.S. Nuclear Regulatory Commission, Washington, DC 20555, and should clearly state on the envelope and in the letter that it is an "Appeal from an Initial FOIA Decision."

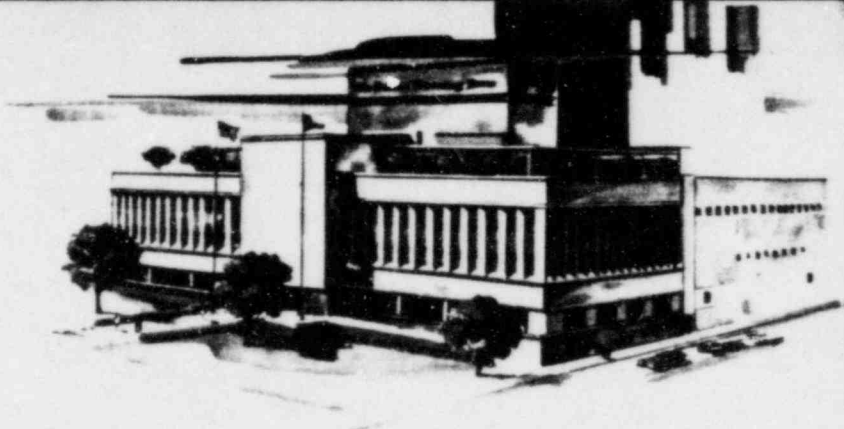
