SUBJECT: MEETING SUMMARY - INSPECTION REPORT NO. 50-302/84-27

This refers to the enforcement conference conducted, at our request, in the NRC Region II Office on September 6, 1984. This meeting was held to discuss the issues concerning; (1) the August 15, 1984 security event, (2) adherence to procedures, and (3) calibration program deficiencies.

It is our opinion that this meeting was beneficial and has provided a comprehensive understanding in all areas.

The August 15, 1984 security event will be summarized in Inspection Report 50-302/84-23. The areas of adherence to procedures and calibration concerned the NRC from the standpoint that in each area, several severity level IV violations had been issued which indicated a trend toward poor performance. Your presentation has reasonably assured us that your management is applying the proper attention and we would expect to see a decrease in NRC citations.

In accordance with Section 2.790 of NRC's "Rules of Practice," Title 10, Code of Federal Regulations, a copy of this letter will be placed in the NRC's Public Document Room.

Should you have any questions concerning this matter, we will be pleased to discuss them.
