SAFETY EVALUATION REPORT CONFIRMATORY ITEM NO. 36 (13.3.2.12) HOPE CREEK GENERATING STATION DOCKET NO. 50-354

At the staff's request, the Salem Memorial Hospital (SMH) Radiation Emergency Plan, which is referred to in Section 13.2 of the Hope Creek Generating Station Emergency Plan, was submitted to the NRC on September 5, 1984. On September 20, 1984, the staff discussed this hospital plan with Public Service Electric and Gas Company and requested that certain portions of the plan be clarified.

Public Service Electric and Gas Company (PSE&G) has had SMH and Radiation Management Corporation (RMC; prepare revisions to the hospital plan and hereby submits the enclosed SMH plan, entitled, "Decontamination and Treatment of the Radioactively Contaminated Patient at Salem County Memorial Hospital", Revision of October 1984. The following items within this revision are provided as response to the staff's requests resulting from the discussions of September 20, 1984:

- Provide procedures to verify the authenticity of 0 alert/notification calls from the plant to SMH (See Procedure Section E.1).
- Provide a caution concerning the collection of 0 contaminated materials (See Attachment E, Section C.3.)
- Add Dr. Fullerton to the Radiation Emergency 0 Telephone Directory (See Attachment H).

Revision 5 of the Hope Creek Generating Station Emergency Plan was submitted by letter, R. L. Mittl, PSE&G, to A. Schwencer, NRC, dated November 9, 1984. This revision included responses to SER Confirmatory Item No. 36 Sections 13.3.2.6 (Description of Emergency Communications), 13.3.2.8 (Support and Resources provided by Salem Generating Station), and 13.3.2.15.

Revision 6 of the Hope Creek Generating Station Emergency Plan was submitted by letter, R. L. Mittl, PSE&G, to A. Schwencer, NRC dated January 16, 1985. This revision included responses to SER Confirmatory Item No. 36 Sections 13.3.2.4, 13.3.2.6 (Location of Emergency Communication), and 13.3.2.9 (Instruments and Plant Parameter Values).

Responses to Confirmatory Item No. 36 Sections 13.3.2.1, 13.3.2.5, 13.3.2.7, 13.3.2.8 (TSC and OSC Information), 13.3.2.8 (Onsite Monitoring Systems), 13.3.2.9 (Portable Instrumentation), and 13.3.2.9 (Radiation vs Time Curves) will be incorporated in the HCGS Emergency Plan by June 1985.
