Relocation of Component Lists

Gentlemen:

Enclosed is a supplement to the License Amendment Request submitted on June 19, 1992 (letter PY-CEI/NRR-1474L) for the Perry Nuclear Power Plant (PNPP) Unit 1 Facility Operating License NPF-58.

The June 19, 1992 Amendment Request proposed the modification of PNPP's Unit 1 Technical Specifications by relocating the component lists from Technical Specification Sections 3.6.4 (Table 3.6.4-1, Containment Isolation Valves) and 3.8.4.1 (Table 3.8.4.1-1, Containment Penetration Conductor Overcurrent Protective Devices) in accordance with the guidance set forth in NRC Generic Letter 91-08, "Removal of Component Lists from Technical Specifications." The subject component lists are to be relocated to PNPP's Operations Manual and made subject to the change control provisions for procedures as described in the Administrative Controls Section of PNPP's Technical Specifications.

In order to accomplish the relocation of the subject component lists, the June 19, 1992 Amendment Request also proposed the modification of several additional Specifications which contained specific references to the Table numbers of the component lists that are being relocated.

This Supplement identifies two additional modifications to PNPP's Technical Specifications to remove additional references to the Table numbers of the component lists that are being relocated. Attachment 1 contains a description of the proposed changes. Copies of the marked up Technical Specification pages are provided in Attachment 2. The Safety Assessment, and the Significant



RELOCATION OF COMPONENT LISTS)

I. DESCRIPTION OF PROPOSED CHANGES

- A. Technical Specification Table 3.3.7.5-1, Accident Monitoring Instrumentation, footnote *** (page 3/4 3-76) is modified consistent with the guidance contained in Generic Letter 91-08 to remove the reference to "Table 3.6.4-1,a." Table 3.6.4-1,a, will be relocated to PNPP's Plant Data Book in the manner described in the License Amendment Request dated June 19, 1992. Refer to Attachment 2, page 1 of 3, for the copy of Technical Specification Table 3.3.7.5-1 as modified.
- B. Technical Specification 3.6.4, Containment Isolation Valves, ACTION a (page 3/4 6-28) is modified consistent with the guidance contained in Generic Letter 91-08 to remove the reference to Table 3.6.4-1 contained in the first sentence of the ACTION statement. Refer to Attachment 2, page 2 of 3, for a copy of Technical Specification 3.6.4 containing the modification described above, in addition to the modifications previously submitted in the June 19, 1992 Amendment Request. Attachment 2, page 3 of 3 is not revised by this SUPPLEMENT, but is included for completeness.
