In view of the Licensing Board's recent Order of October 19, 1984 scheduling the commencement of hearings on offsite emergency planning contentions for November 19, 1984, I suggest that we meet in Philadelphia on Monday, October 29, 1984 to discuss and resolve prehearing matters.

As you are aware, the Board has previously encouraged the parties to have such meetings, and has similarly urged the parties to do so in its most recent Order (p. 3).


