SUBJECT: SUMMARY OF MEETING WITH APPLICANT TO DISCUSS LOCA LOADS

AND LOAD COMBINATIONS USED IN DESIGN OF MILLSTONE 3

PIPE AND COMPONENT SUPPORTS

On September 13 and 14, 1984 members of the NRC Staff held a meeting with Northeast Nuclear Energy Company at the Millstone 3 site in Waterford, Connecticut. The NRC staff was represented by members of the Division of Engineering, Mechanical Engineering Branch and the Division of Licensing. The applicant was represented by members of Northeast Nuclear Energy Company, Stone & Webster Engineering Corporation and Westinghouse. A list of attendees is Enclosed.

The purpose of this meeting was to obtain clarification of load combinations used in the design of the reactor coolant loop heavy component supports. This information is discussed in Section 3.9.3 of NUREG-1031, "Safety Evaluation Report related to the operation of Millstone Nuclear Power Station, Unit No. 3."

As a result of the meeting, the staff obtained an understanding of the scope of the applicants contemplated request for exemption from GDC 4 and the need to consider double-ended guillotine breaks in the reactor coolant loop for Millstone 3; the Westinghouse/Stone & Webster design responsibility interface; the LOCA design considerations for the reactor coolant loop attached branch lines; and errors in calculations associated with design of the load path for the reactor coolant pump (P1) snubber support.

At the close of this meeting the applicant stated that it would perform additional analyses associated with the reactor coolant pump (P1) snubber support, and therefore this item should not be considered by the staff in its review of the applicants request for exemption from GDC #4.

Additionally, the staff stated that it is currently considering a request for exemption from GDC 4 for Vogtle involving LOCA design considerations for the reactor coolant loop attached branch lines, and stated that the staffs conclusions regarding the Vogtle exemption request would be considered in the review of the Millstone request.

The applicant plans to submit a revised request for exemption after completing the analyses on the Pl snubber support.
