The DLA Civil Preparedness Office was disestablished effective 30 March 1984. Accordingly, we wish to cancel our NRC license number 45-14910-02.

All radioactive materials and devices were shipped to State Radiological Systems Maintenance Facilities and to Oak Ridge National Laboratory. Disposal action was accomplished on unwanted materials through and by U. S. Army Armament Munitions and Chemical Command, Rock Island, IL.

The radioactive storage room, maintenance shop, and wipe testing areas were surveyed and found to be free of any residual activity.
