This refers to the routine inspection conducted by Frederick Paulitz of this office on July 30 - August 2, 1984, at Peach Bottom Atomic Station, Units 2 and 3, of activities authorized by NRC License No. DPR-44 and DPR-56 and to the discussions of our findings held by F. Paulitz with Mr. Fleischmann of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

Within the scope of this inspection, no violations were observed.
