Between July 3 and August 3, 1984, Mr. R. Conte and other NRC representatives conducted a routine safety inspection of activities authorized by NRC License No. DPR-50 at your facility. The attached NRC Region I Inspection Report describes the areas examined. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector. At the conclusion of the inspection, Mr. Conte summarized the inspection findings to you and other members of your staff. Within the scope of this inspection, no violations were observed.

Your letter of June 23, 1984 adequately responded to our letter of May 31, 1984, concerning the violation resulting from failure to properly install a welded vent cap on a storm drain next to the TMI-2 Condensate Storage Tank (designated for TMI-1 use). Further, our inspector verified your corrective steps for the specific item and your corrective steps to avoid further violation. We concur with your characterization of the event as an isolated case. We have no further questions or comments, but we will continue to closely monitor your performance in the proper implementation of work instructions related to important to safety systems.
