Subject: Inspection No. 30-09062/84-01

This refers to the routine safety inspection conducted by Ms. Jenny M. Johansen and Mr. Edwin A. Wurtz of this office on August 27, 1984, of activities authorized by NRC License No. 20-00742-18 and to the discussions of our findings held by Ms. Johansen with yourself, Dr. Kolodny, Ms. Jansons and Mrs. Kennedy of your staff at the conclusion of the inspection, and to a subsequent telephone discussion between yourself and Mr. James Joyner of my staff on September 21, 1984.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements, as discussed in the enclosed inspection report. We are considering appropriate enforcement actions for these apparent violations and will advise you later of our decision.

This letter also confirms that an Enforcement Conference will be conducted in our Region I Office on October 15, 1984, at 10:30 a.m., to discuss these violations. At that Enforcement Conference you should be prepared to discuss the causes of the violations and your proposed corrective actions. The NRC enforcement policy is described in Appendix C of 10 CFR Part 2, a copy of which is enclosed for your information.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
