Subject: Inspection No. 50-247/84-22

This refers to the routine safety inspection conducted by Mr. P. Clemons of this office on August 16-17, 1984 at Buchanan, New York, of activities authorized by NRC License No. DPR-26 and to the discussions of our findings held by Mr. Clemons with Mr. Jackson and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector. We also examined the circumstances surrounding the August 7, 1984 unplanned exposure of a worker.

Based on the results of this inspection, it appears that certain of your activities were not conducted in full compliance with NRC requirements. The Notice of Violation associated with these activities will be provided at a later date in separate correspondence.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.

The responses directed by this letter and the accompanying Notice are not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
