Dear Members of the Shoreham Appeal Board:

The Commission this morning voted 4-1 to permit the Miller Board's October 29 Initial Decision to become effective. 1/1 In view of the NRC's ruling, we are filing with this Board 1/1 "Suffolk County and State of New York Motion for Stay of Miller Board Decision." 1/1

We request an expedited decision on this Motion. The Commission stated this morning that the license will be issued unless by 5:00 p.m. tomorrow, an emergency stay motion is filed in the United States Court of Appeals. We are prepared to file such an emergency motion by 5:00 p.m. tomorrow if an agency stay has not been granted. However, we of course are anxious to avoid filing unnecessary papers with the Court. Thus, we require a ruling on the instant motion by 11:00 a.m. tomorrow.
