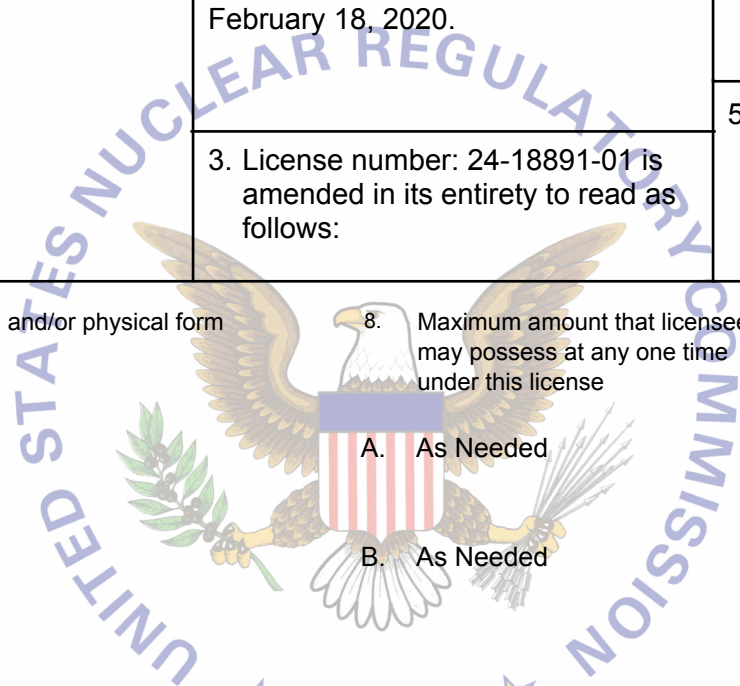


MATERIALS LICENSE

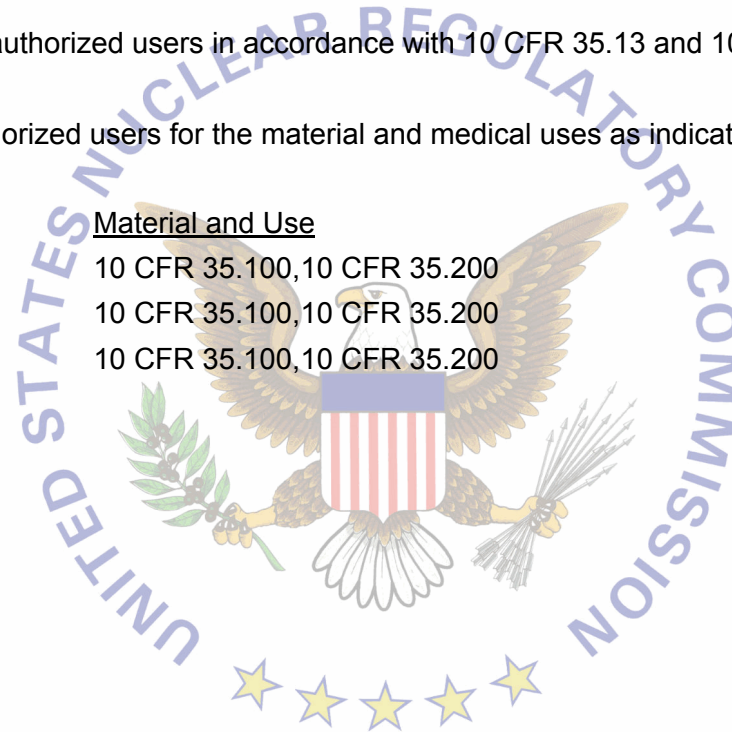
