Gentlemen:

This refers to the inspection conducted by Mr. James Kelly of this office during the period August 13-17, 1984, of activities authorized by NRC Construction Permit CPPR-103, for Waterford-3 Steam Electric Station, and to the discussion of our findings with Mr. R. P. Barkhurst and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included security-related testing and maintenance and assessment aids. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.
