This refers to a meeting and emergency response facility tour held with your staff at the Wolf Creek Generating Station during the week of July 30 through August 3, 1984, by Mr. C. A. Hackney of the Region IV Emergency Preparedness staff. The purpose of this inspection was to discuss the emergency preparedness program and to determine the progress your staff had made in preparation for the preoperational inspection that will be conducted prior to a decision for a license to load fuel.
