Gentlemen:

This refers to the inspection conducted by Ms. C. Abigail Evans of this office during the period August 14-17, 1984, of activities authorized by NRC Operating Licenses DPR-51 and NPF-6 for Arkansas Nuclear One, Units 1 and 2, and to the discussion of our findings with Mr. J. M. Levine and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included a review of the security organization, security hardware testing, and package searches. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.
