This transmits the July 11 - August 20, 1984 resident inspection findings by Messrs. T. Foley and D. Trimble at the Calvert Cliffs Nuclear Power Plant, Lusby, Maryland. Those findings were based on observation of activities, interviews, independent measurements, and document reviews, and have been discussed with Mr. Russell of your staff.

Based on the results of this inspection, it appears that one of your activities was not conducted in full compliance with NRC requirements, as set forth in the Notice of Violation, enclosed herewith as Appendix A. This violation has been categorized by severity level in accordance with the revised NRC Enforcement Policy (10 CFR 2, Appendix C) published in the Federal Register (47 FR 9987) dated March 8, 1984. This notice is sent to you pursuant to the provisions of Section 2.201 of NRC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations. Although Section 2.201 requires you to submit to this office, within 30 days of your receipt of this notice, a written statement of explanation, we note that this violation was corrected prior to the completion of our inspection, and therefore, no response with respect to this matter is required.

In addition, we have reviewed your letter, dated July 30, 1984, in response to our letter, dated July 3, 1984, (Inspection Report No. 84-11). Thank you for informing us of the corrective and preventive actions documented in your letter. These actions will be examined during future inspection of your licensed program.

Your cooperation with us is appreciated.
