Your letter of August 15, 1984 requested a schedule extension of 37 days for submitting the information concerning Hatch Units 1 and 2 diesel generator reliability requested by our Generic Letter 84-15. You cited, among other things, the heavy workload at the plant site and corporate office for the Unit 2 recirculation pipe replacement outage along with preparation for the Unit 1 outage scheduled for the fall of 1984, as the basis for your request.
