SUBJECT: MEETING SUMMARY - VOGTLE FACILITY, DOCKET NOS: 50-424 AND 50-425

This refers to the management meeting conducted, at your request, in the Georgia Power Company office on September 6, 1984. This meeting was held to discuss the establishment of possible milestones for the proposed development of a pilot program to verify the adequacy of construction activities at Vogtle.

The main concept proposed by Georgia Power Company, as discussed during this meeting, centered on the establishment of a pilot program that would develop and utilize a readiness review concept. The readiness review concept encompasses the establishment of many separate areas, in which implementation criteria would be submitted to the NRC in a detailed manner.

It was noted that this meeting was only an exchange of ideas on a concept to improve the regulatory atmosphere under which a plant is constructed. Such a program at Vogtle could be a pilot program, which could benefit all concerned organizations. The industry could possibly gain by the development of methods and techniques that define implementation for construction and testing criteria. This would, according to the licensee, reduce the risk an applicant faces.

The decision was made by NRC to participate further with Georgia Power Company to better understand and define the proposal.

It is our opinion that this meeting was beneficial and has provided for a better understanding of your proposed changes.

In accordance with Section 2.790 of NRC's "Rules of Practice", Title 10, Code of Federal Regulations, a copy of this letter will be placed in the NRC's Public Document Room.
