This refers to the routine inspection conducted by Mr. J. R. White of this office on November 26-30, 1984 at the Salem Nuclear Generating Station of activities authorized by NRC License No. DPR-70 and DPR-75 and to the discussions of our findings held by Mr. White with Mr. E. A. Liden of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Relative to our post-implementation review of your post-accident sampling and monitoring capabilities, no violations were identified. However, certain activities require improvement to be acceptable relative to NUREG-0737. You are requested to review the items identified in this report and respond within 25 days of the date of this letter on actions planned or taken in regard to these items.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room.
