Subject: Enforcement Conference Report Nos. 50-277/84-27 and 50-278/84-23

This refers to the enforcement conference held at the NRC Region I Office, in King of Prussia, Pennsylvania, on July 31, 1984, to discuss the apparent violations of NRC requirements identified in our Combined Inspection Report Number 50-277/84-19 and 50-278/84-10, dated July 25, 1984. The meeting was attended by you and members of your staff and by Dr. T. E. Murley, Regional Administrator, myself and members of the Region I staff.

It is our view that this meeting was beneficial and improved our mutual understandings of the apparent violations and regulatory concerns. A summary of the issues discussed at this meeting and the additional information you presented are documented in the enclosed Region I Enforcement Conference Report Nos. 50-277/84-27 and 50-278/84-23.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosed report will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, U.S. NRC Region I, at (215) 337-5223.

No reply to this letter is required. Your cooperation with us in this matter is appreciated.
